4. OBJETIVO GENERAL DE LA ASIGNATURA

To provide techniques the students need to carry out a contrastive analysis at a phonological level.

To develop in the students the skills to apply some of the theoretical and practical aspects dealt with in the English Phonology Course.

5. OBJETIVOS ESPECÍFICOS DE LA ASIGNATURA

We will investigate the effects of phonological transfer processes on the interlanguage of a sample of Spanish-speaking learners of English through the analysis of recorded material (texts and subjects change from one season to another)

Problems such as the identification and evaluation of errors, the significance of contrastive information, and the conditions in which transfer processes occur in language learning situations will be discussed in the light of the recorded material.

Finally, students will use contrastive information to hypothesize on potential sources of error.
